Integration in network communications: Dibella is involved in numerous initiatives, talks to the media, exchanges information with NGOs and, if desired, integrates its customers into this large network.

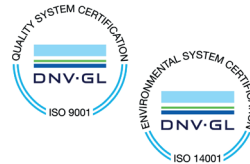
